

PRIVACY POLICY

We are committed to preserving the privacy of all visitors and users of this website. We may disclose your information to the following parties:

- 1. The Financial Conduct Authority FCA and other regulatory and government bodies;
- 2. Other companies within our group;
- 3. Service providers and professional advisers who provide us with services;
- 4. Any other third parties where this is necessary in order to provide the products or services requested by you;
- 5. Any other party authorized by you;
- 6. Any authority we are required to disclose information to by law.



Unless required to do so by law, we will not otherwise share, sell or distribute any of the personal information you provide to us without your consent. We will not disclose personal information to a third party for their marketing purposes.

When you visit this website we may issue a "cookie" to your computer. This is a small program that allows us to identify your computer.
